ORDINANCE No. 16 – 07

ORDINANCE PROVIDING FOR AN APPROPRIATION OF \$53,000 FROM THE GENERAL CAPITAL FUND, CAPITAL FUND BALANCE ACCOUNT TO FINANCE THE COST OF VARIOUS CAPITAL PROJECTS IN AND BY THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF BERGEN, NEW JERSEY, AS DESCRIBED HEREIN

WHEREAS, the sum of \$53,000.00 is presently available in the General Capital Fund, Capital Fund Balance Account; and

WHEREAS, the Business Administrator has determined that such sum should be appropriated for the projects hereafter listed; and

WHEREAS, it is the opinion of the Council that it is in the best interests of the Township of Washington to utilize the said sum of \$53,000.00 In the General Capital Fund, Capital Fund Balance Account, to finance such improvements.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington in the County of Bergen, State of New Jersey as follows:

SECTION 1. The total sum of \$53,000.00 is hereby appropriated from the General Capital Fund, Capital Fund Balance Account, to finance the following projects:

Demolition and Reconstruction of Retaining Wall at Fire House	\$35,500
Scott Air Paks – Fire Department	\$7,500
Siding Replacement Fire House	\$10,000
Total	\$53,000.00

SECTION 2. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.


SECTION 3. If any section, sub-section, paragraph, sentence or any other part of this ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

SECTION 4. All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.


SECTION 5. This ordinance shall take effect twenty (20) days after the first publication thereof after final passage.
