ORDINANCE NO. 16 – 10

AN ORDINANCE AMENDING CHAPTER 197 OF THE TOWNSHIP
CODE IN ORDER TO ESTABLISH A REVISED PLASTIC BAG
SYSTEM FOR SOLID WASTE COLLECTION WITHIN THE
TOWNSHIP OF WASHINGTON

BE AND IT IS HEREBY ORDAINED by the Township Council of the Township of Washington that Section 197-3 of Chapter 197 of the Code of the Township of Washington entitled "Solid Waste Collection" be and is hereby amended in its entirety as follows:

1. §197-3 "Single-family housing.

In the case of single-family residential housing located within the Township, each responsible solid waste generator shall enter into a contract for regular solid waste collection service with any person or entity lawfully authorized to provide solid waste collection services within the Township, provided that such solid waste collector shall have in effect a system wherein sealed plastic bags are used for waste collection."

2. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not affect the remaining portions of this Ordinance.

3. All Ordinances or any provisions of any ordinance inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies and not otherwise.

4. This Ordinance shall take effect upon final passage and publication and in accordance with the Charter, and subject to such emergency resolution as may be adopted pursuant to Section 17-32 thereof. [R.S. 40:69A-181 (b)].
