WHEREAS, on June 21, 2017, the Township of Washington, County of Bergen, New Jersey received bids for the construction of ADA Compliant Ramps at Memorial Field pursuant to the Advertisement for Bid#17-03 and the related Bid Specifications (the "Project"); and

WHEREAS, the Project is being funded through a non-matching federal grant in the amount of \$50,000 through the Bergen County, Division of Community Development; and



NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Bergen, New Jersey that the bid of Wetlands be and is hereby accepted and a contract is awarded to Wetlands for the Project in the contract amount of \$36,065.00; and


BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute a Contract with Wetlands for the above-stated purpose consistent with said bid.
