ORDINANCE No. 20-02

**AN ORDINANCE AMENDING CHAPTER 15 OF THE CODE OF THE
TOWNSHIP OF WASHINGTON (CRIMINAL HISTORY BACKGROUND
CHECKS) ELIMINATING FINGERPRINTING AS A REQUIREMENT**

BE IT ORDAINED, by the Township Council of the Township of Washington, that Chapter 15 (Criminal History Background Checks) of the Code of the Township of Washington is hereby amended as follows:

1. The definition of "Criminal History Record Background Check" under § 15-1 [Definitions] is hereby amended as follows:

"CRIMINAL HISTORY RECORD BACKGROUND CHECK


A determination of whether a person has a criminal record by cross-referencing that person's name with those on file with the Federal Bureau of Investigation, Identification Division, and/or the New Jersey State Bureau of Identification in the Division of State Police. Fingerprinting shall not be a requirement in connection therewith."

2. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not affect the remaining portions of this Ordinance.
3. All Ordinances or any provisions of any ordinance inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies and not otherwise.
4. This Ordinance shall take effect upon final passage and publication and in accordance with the Charter, and subject to such emergency resolution as may be adopted pursuant to Section 17-32 thereof. [R.S. 40:69A-181 (b)].
