ORDINANCE NO. 22-02

**AN ORDINANCE AMENDING PARKING RESTRICTIONS IN THE
AREA OF THE JESSIE F. GEORGE SCHOOL**


BE IT ORDAINED, by the Township Council of the Township of Washington, that Section 223-54 (Jessie F. George School) is hereby amended by adding a new sub-section "F" and re-lettering the currently existing sub-section "F" as more particularly set forth below:

1. Current sub-section "F" is hereby revised to forthwith become sub-section "G" in § 223-54.
2. There is hereby established as new sub-section "F" in § 223-54, the following:
"F. No vehicle shall park on the north side of Palm Street (westbound lane) from the Jessie F. George School exit driveway to the corner of Beech Street from 8:00 a.m. to 4:00 p.m. on school days. No vehicle shall park on the south side of Palm Street (eastbound lane) from 535 Palm Street to the intersection with Walnut Street and continuing south on Walnut Street to the corner of Cypress Street from 8:00 a.m. to 4:00 p.m. on school days."
3. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not affect the remaining portions of this Ordinance.
4. All Ordinances or any provisions of any ordinance inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies and not otherwise.
5. This Ordinance shall take effect upon final passage and publication and in accordance with the Charter, and subject to such emergency resolution as may be adopted pursuant to Section 17-32 thereof. [R.S. 40:69A-181 (b)].




