**AN ORDINANCE REQUIRING AN ADDITIONAL FEE FOR
NON-RESIDENT PARTICIPANTS IN RECREATION PROGRAMS**

BE IT ORDAINED, by the Township Council of the Township of Washington, that Sub-section B of Section 212-1 Chapter **7** (Office of Recreation) of the Code of the Township of Washington is hereby amended in its entirety as follows:

1. “

(1) The following fee schedule shall apply to participants in the recreational activities administered through the Office of Recreation:

Flag football	\$55	\$50
Cheerleading	\$140	\$130
Intro to cheerleading	\$50	\$45
Basketball (intramural)	\$155	\$145
Basketball (traveling)	\$170	\$160

Basketball (fall clinic)	\$50	\$45
Lacrosse	\$145	\$130
Lacrosse (instructional)	\$50	\$45
Men's softball	\$50	

For any program not listed above, a minimum fee of \$50 for each participant.

Summer recreation program (8:30 a.m. to 2:30 p.m.) (6-week program) <i>(See below for Out-of-Town registration)</i>	\$440	\$430

Fees for extra activities within the Program vary based on the activity.

Full before and after care (7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 6:00 p.m.)	\$650	\$625
Full before care only (7:30 a.m. to 8:30 a.m.)	\$220	\$200
Full after care only (2:30 p.m. to 6:00 p.m.)	\$500	\$475
Fee for late pickup (paid at end of week)	\$25 per hour for each participant	
Out-of-Town registration (Includes any participants who are not residents of the Township of Washington)		
Summer recreation program (8:30 a.m. to 2:30 p.m.)	\$550	\$540
Summer recreation before- and after-care programs:		
Full before and after care (7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 6:00 p.m.)	\$770	\$750
Full before care only (7:30 a.m. to 8:30 a.m.)	\$300	\$280
Full after care only (2:30 p.m. to 6:00 p.m.)	\$575	\$550
Fee for late pickup (paid at end of week)	\$35 per hour for each participant	

Prorated refunds will be issued only during the first two weeks of the program. After the first two weeks of the program, registration fees are nonrefundable.


- (2) Refunds. There shall be a \$25 per-registration refund fee. Refunds shall only be issued if requested in writing within the first two weeks of a program and during the first week of summer recreation. No refund will be issued for before and after care after the start of the program. No refunds will be issued for summer recreation trips/excursions.
 - (3) Non-resident Participants. In addition to each Program fee payable by a Participant as set forth above, with the exclusion of the Summer Rec program that has its own non-resident rates, each non-resident Participant shall be required to pay an additional fee of \$25.”
2. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not affect the remaining portions of this Ordinance.
 3. All Ordinances or any provisions of any ordinance inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies and not otherwise.






