ORDINANCE NO. 22-16

**AN ORDINANCE AMENDING THE TABLE OF ORGANIZATION OF
THE POLICE DEPARTMENT OF THE TOWNSHIP OF WASHINGTON**

BE IT ORDAINED, by the Township Council of the Township of Washington, that Subsections A and B of Section 72-1 (Organization and Structure) of Chapter 72 (Police Department) of the Code of the Township of Washington is hereby amended by deleting the current Subsections and replacing same with the following:

1.

“§ 72-1 Organization and structure.

A. The Police Department of the Township of Washington shall consist of the following descending rank structure:

- (1) Chief of Police.
- (2) Deputy Chief of Police
- (3) Captain.
- (4) Lieutenant.
- (5) Sergeant
- (6) Corporal.
- (7) Police Officer.

B. Within the aforesaid rank structure, the Police Department shall consist of the following:

- (1) One Chief of Police.
- (2) One Deputy Chief of Police or One Captain.
- (3) Not more than two Lieutenants.
- (4) Not more than six Sergeants
- (5) Not more than five Corporals

(6) A number of Police Officers as needed not to exceed a total of 22 Officers of all ranks.”


2. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not affect the remaining portions of this Ordinance.


3. All Ordinances or any provisions of any ordinance inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies and not otherwise.

4. This Ordinance shall take effect upon final passage and publication and in accordance with the Charter, and subject to such emergency resolution as may be adopted pursuant to Section 17-32 thereof. [R.S. 40:69A-181 (b)].
