THE TOWNSHIP OF WASHINGTON ANNOUNCES TEMPORARY SUSPENSION OF
ALL PERMIT AND INSPECTION REQUIREMENTS FOR THE SALE OF RESIDENTIAL
HOMES

ALL PERMIT AND RENTAL INSPECTIONS FOR A CHANGE OF TENANCY ARE ALSO
SUSPENDED

RESIDENTIAL HOME SALE CCO AND FIRE INSPECTIONS

Effective Monday, March 16, 2020, and until further notice, the Township of Washington is temporarily suspending requirements for the sale or transfer of residential homes, including Certificate of Continued Occupancy (CCO) and Certificate of Smoke and Carbon Monoxide Detector Compliance (CSCMDC) inspections.

This notice shall serve as an official waiver for both the CCO and CSCMDC certificates and the sale or transfer of residential property within the Township of Washington shall otherwise not be impeded by any municipal obligation.

All existing inspection appointments are hereby cancelled.

All persons or entities that transfer title without these inspections during this emergency do so at their own risk and the Township of Washington disclaims any liability. Homeowners or their agent should fill out a form in lieu of the inspections and submit it to the Building Department via mail or drop box. Please contact Building Department at (201) 666-0462 to arrange pick up, mail, or email of the form.

CONSTRUCTION PERMITS AND INSPECTIONS

There are no inspections being scheduled at this time and until further notice. All existing inspections have been cancelled.

Permits must still be filed for all work which typically requires a permit and should be submitted by either mail or drop box located outside of the municipal building. Permit documents can be downloaded through the following link:
